The Government of Uzbekistan has received a loan from the International Development Association (IDA) to cover the costs of the project “Reconstruction of district heating system and energy efficiency in the cities of Andijan, Chirchik, Bukhara, Samarkand and Tashkent (TC-8)” and intends to allocate part of the funds to finance eligible payments under the contract for the modernization of the Boiler House "Jubileyniy", purchase and installation 3-th gas-fired heat pipe boilers 75 MW, replacement of 1,997 meters of heat networks from pre-insulated pipes, installation of 15 sets of individual heat supply points (IPPs) with heat energy metering devices, as well as reconstruction of electric and water supply networks in the city Chirchik:
